# 2019 Lenczner Slaght/CLA Gale Cup Moot Takes Place February 15-16

The Lenczner Slaght/CLA Gale Cup Moot, one of Canada's most prestigious bilingual law school mooting competitions, takes place February 15-16 at Osgoode Hall in Toronto, with 18 law schools from across Canada participating.

The competition will open with a special welcome reception in the lobby of Lenczner Slaght's offices on Friday, February 15. "The Gale Cup offers young advocates the chance to test their skills at the beginning of their careers," said Tom Curry, managing partner of Lenczner Slaght. In addition to the Gale Cup and other team and individual awards, the McLachlin Prize will be awarded to the best female mooter on Saturday, February 16 at Osgoode Hall. The Honourable Justice Sheilah Martin of the Supreme Court of Canada will deliver the after-dinner keynote address at the gala awards banquet.

This year's case is *R v Marakah*. In *R v Marakah*, 2017 SCC

59, a search warrant led to the discovery of text messages Nour Marakah had sent to his accomplice about trafficking a firearm located on his accomplice's cell phone. At Marakah's trial, the prosecution tried to rely on the evidence illegally found on his accomplice's phone to convict him. Marakah asserted that he retained a privacy interest over the text messages, even after the messages reached their destination on the cell phone of his accomplice. The Supreme Court of Canada agreed that privacy interests can attach to cell messages found on someone else's phone and overturned his convictions. In a 7-2 decision, the majority of the Supreme Court found that Marakah retained a privacy interest in his text messages and therefore had standing to challenge the search and the admission of the evidence of the text messages recovered from the phone. The dissenting Justices concluded Marakah did not have a reasonable expectation of personal privacy in his text message conversations once they were sent and therefore lacked standing to challenge the search of his accomplice's phone. They would have admitted the evidence of gun trafficking and upheld the criminal convictions.

Students taking part in the Lenczner Slaght/CLA Gale Cup Moot are permitted to moot in either English or French, with simultaneous translation provided for oral arguments.
