- **Talk Isn't Cheap: Ontario Court of Appeal Upholds Oral Agreement for the Sale of Land** – In its recent judgment in *2730453 Ontario Inc v 2380673 Ontario Inc*, the Ontario Court of Appeal upheld the trial decision of the Honourable Justice Centa, which awarded specific performance to the Purchaser (successfully represented by Lenczner Slaght) for the Vendor's breach of an oral agreement for the purchase and sale of a 32-acre parcel of land for development. In doing so, the

Court clarified the legal requirement that a prospective purchaser must prove “detrimental reliance” in undertaking acts of part performance before an oral agreement will be enforced in the face of the *Statute of Frauds*.
