### **SELECT CASES**

- ➤ Abbasbayli v Fiera Foods Company et al Trial counsel to the defendant companies and corporate directors in a wrongful dismissal action brought by a former employee. The employee's action was dismissed. The defendants were successful at trial in establishing the employee had perpetrated wilful misconduct justifying termination for cause.
- ➤ Canadian News Media Companies v OpenAI Counsel to Canada's leading news media organizations in their legal action against OpenAI for breach of copyright, breach of online terms of use, breach of contract, and unjust enrichment for scraping large swaths of content (millions of works) from Canadian media to help develop its products, such as



ChatGPT.

- ▶ Bell Media Inc et al v Warner Bros. Discovery et al Counsel to the Warner Bros. Discovery entities responding to Bell Media Inc.'s request for a permanent injunction seeking to prevent Warner Bros. Discovery from licensing television content to Rogers Communications Inc.
- ➤ University of Toronto (Governing Council) v Doe et al Counsel to the University of Toronto in successfully bringing an interlocutory injunction to bring a peaceful end to the encampment that occupied the green space known as Front Campus for over 50 days. The University successfully argued that it was the private property owner of Front Campus and entitled to enforce its property rights over the protestors residing in the encampment. The University also successfully argued that its actions in respect of the encampment were not subject to the application of the Charter.
- ➤ Chief James Marlowe and the Lutsel K'e Dene First Nation v Mirza Mohammad Imran Karim Barlas et al – Counsel to the Lutsel K'e Dene First Nation and its elected chief in an oppression application (and related injunction) arising from allegations of breach of fiduciary duty, misappropriation, and fraud by the CEO of the First Nations' company.
- ➤ Mittra v Royal Bank of Canada et al Counsel to RBC in this \$10 million wrongful dismissal claim. After a three-week trial, the Court held that RBC had just cause to dismiss the plaintiff without notice. Reported at 2024 ONSC 636.
- ➤ Metro Ontario Inc v Mouzakitis et al Counsel to Metro Ontario Inc. successfully obtaining a Mareva injunction and Anton Piller Orders, against former employees for breach of contract, breach of fiduciary duties, and fraud.
- ➤ Libfeld v Libfeld Counsel to the successful partner of a multi-billion dollar residential and commercial real estate developer and builder in obtaining successful order winding up and selling the partnership.
- ➤ Crosslinx v Metrolinx Counsel to Crosslinx Transit Solutions
  Constructors in an application against Metrolinx and Ontario
  Infrastructure (HMQE) in relation to HMQE's failure to declare an
  emergency as a result of the COVID-19 pandemic. Crosslinx is a design
  and construction consortium established to deliver and maintain the
  Eglinton Crosstown LRT, the second largest Canadian transit
  infrastructure project. We successfully resisted a motion to stay and
  succeeded entirely on the application to obtain contractual relief due to
  the pandemic. This is notable as it may have broader implications for
  other P3 Projects across the province of Ontario.
- ▶ Re Investment Management Corporation of Ontario Trial counsel to IMCO in a breach of contract claim with manager of public infrastructure projects.
- ➤ Wintercorn v Global Learning Group Inc; Piett v Global Learning Group Inc — Counsel to a defendant law firm in a class proceedings in Ontario and Saskatchewan relating to a tax donation program.
