This past year, she balanced her legal studies with clinic-volunteering and mooting. She served as a manager for Artists' Legal Advice Services, a clinic that provides free legal assistance to artists across Ontario and volunteered as a caseworker in the Employment and Academic Appeals Division of Downtown Legal Services. Lauren has competed in the Willms & Shier Environmental Law Moot, the Hamish Stewart Cup and participated in the first-year Trial Advocacy Program.

Herschel Chalet is a third-year student at Western University, Faculty of Law. Herschel has worked as a research assistant for Professor Stephen G.A. Pitel, where he investigated the impact of Canadian law on the recognition and enforcement of foreign judgments in the common law world, and as a staff editor for the Western Journal of Legal Studies. He has successfully competed in several trial and appellate advocacy competitions, including the Legate Medical Malpractice Moot, the Cherniak Cup, the Lerner LLP Cup, and the Gale Cup Moot.

Mackenzie Faulkner has completed his second year at the University of Toronto, Faculty of Law. During law school, he participated in the 2021 Grand Moot and won the 2022 Hicks Morley Labour Moot. His clinic work includes working with Advocates for Injured Workers, to represent low-income

workers appealing WSIB decisions, and volunteering with the David Asper Centre for Constitutional Rights. Next year, Mackenzie will be serving on the Moot Court Committee, which runs the school's mooting program, and acting as Co-Chief Justice for the 2022 Grand Moot.

Derek Hooper is a JD candidate at Queen's University, where he also completed his Master's in Political Studies. While at law school, Derek worked as a Student Caseworker at the Queen's Prison Law Clinic, as VP Finance of the Queen's Law Students' Society, and as Associate Editor of Queen's Law Journal.
